- 3. KF performances should be given first preference. The artiste can undertake private performances only with prior permission. Denial to perform for K/F at the appointed place/ time as intimated the KF, will be treated as a valid reason for termination of contract without compensation.
- 4. KF reserves the right to determine the number of artists required and to restrict the number of artists.
- 5. The artist engaged on contract will not have any right, title or interest or intellectual property rights, including copyright in and to the scripts and or the Dance dramas and other productions of KF.
- 6. In case of performances outside, Chennai the lodging and boarding of the artists will be taken care of by K/F.
- 7. The artist engaged on contract shall ensure that while performing his /her obligations and during the tenure of this agreement shall not do any act that is obscene or Liberace or defamatory or derogatory to any religion or belief, contrary to public policy, are capable of straining communal this content / disharmony or in fringe the copyright, right of privacy, right of publicity, moral right, performance right, performance property right or any other right whatever of any person. In the above case, the contract will be terminated with immediate effect without any compensation.
