INSTRUCTIONS TO THE TENDERERS:

- 1. The intending bidder/tenderer must read the terms and conditions carefully. He/she should only submit has bid if he/she considers himself eligible and he/she is in possession of all the documents required.
- 2. The sealed envelope must be super scribed, should have TECHNICAL BID COVER 1 and Check list Name of work: "Extension and repairs to estate office in Kalakshetra Foundation, Thiruvanniyur, Chennai 41." with tender inquiry No. and its due date separately.
- 3. The sealed envelope must be super scribed should have—PRICE BID COVER 2 (financial bid) -Name of work: "Extension and repairs to estate office in Kalakshetra Foundation, Thiruvanmiyur, Chennai 41." with tender inquiry No. and its due date separately
- 4. **Technical and eligibility bid (cover 1) and price bid (cover 2) (financial bid) documents should be submitted separately**. Those who qualifies in the Technical bid are eligible to execute the order and for their price bid only be opened. Should be filled in English and all entries should be typewritten or handwritten but there should not be any overwriting or cutting. Corrections, if any, shall be made by neatly crossing out, initialing, dating and rewriting.
- 5. If any price details indicated in the technical bid invariably their offer will not be considered further
- 6. The rate quoted should be indicated in words as well as in figures. If there is a discrepancy between words and figures, the lesser amount shall be considered as valid. If the tenderer does not accept the correction of the errors, the bid shall be rejected.
- 7. All pages provided in the tender document shall be numbered and submitted as a package along with forwarding letter on agency's/firm's letter head with signed and sealed before their submission.
- 8. Rates should be quoted as shown in format schedule and all applicable taxes and duties levied by government in all respects.
- 9. Tenders qualified by such vague and indefinite expressions such as "subject to prior confirmation", "subject to immediate acceptance" etc. will be treated as vague offers and rejected accordingly.
- 10. The instructions given herein will be strictly binding on the tenderers and deviation, if any, not acceptable to the Kalakshetra Foundation, will make the tender or tenders liable to be considered invalid. Tender(s) incorporating additional conditions by the tenderer(s) are liable for rejection.
- 11. The tenderers shall fill up the **Technical Bid** (**Cover 1**) in prescribed format and submit the same duly signed on all pages and sealed as a token of their acceptance. Incomplete tenders i.e. **Technical Bid eligibility bid** (**Cover 1**) **without** all the supporting documents, EMD and

duly filled in, copy of valid certificates, Copy of GST registration certificate and PAN certificate, Address proof of the firm signed and stamped with official seal in all the pages will be rejected straightway without any reference to the tenderers.

- 12. The tenderers shall quote their rate in words as well as in figures. the cost mentioned in the **Schedule of quantities/BOQ- PRICE BID (Financial Bid) Cover 2** and submit the same duly signed and sealed cover separately. Overwriting in the Price bid (Financial Bid) is not permitted and shall be rejected straightway without any further reference.
- 13. Conditional tenders shall not be accepted.
- 14. Tenders submitted via electronic transmission or through e-mail shall not be accepted.
- 15. In case the last date of receipt/opening of tender is declared as a holiday, then the last date of receipt of /opening of the tenders will be the next full working day.
- 16. The authorities of Kalakshetra Foundation do not bind themselves to accept mere lowest tender and reserves the right to reject or accept any or all tenders wholly or partially without assigning any reason whatsoever.
- 17. The bids shall be valid for a period of **210 days** from the date of opening of the tender.
- 18. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 19. Tender is not transferable. One tenderer shall submit only one tender.
- 20. Tenderer signing the tender must clearly, specify whether he/she is signing as Sole Proprietor, Authorized person, Partner, under Power of Attorney or as Director/ Manager/Secretary etc., as the case may be.
- 21. In case the tenderer fails to submit any of the required documents as per tender document or found unsuitable to execute the tendered job shall not be considered and shall be rejected straight away without any further reference.
- 22. The successful contractor shall not transfer wholly or partially the order of work to any other person(s) / firm / company for any reason whatsoever and in which case the order shall automatically stand cancelled.
- 23. Tender document submitted by the participants should be concise and contain only relevant information as required under this tender.
- 24. The participant would be responsible for all of its expenses, costs and risks incurred towards preparation of the tender document, attending any pre-bid meeting and visiting the site or any other location in connection therewith. Kalakshetra Foundation shall, in no case, be responsible or liable for any such costs whatsoever, regardless of the outcome of the tender process.
- 25. Technical specification as per the tender /schedule, work shall be followed for execution.

GENERAL TERMS AND CONDITIONS

- 1. The successful tenderer shall commence the work within **4 (four)** working days from the date of award of work. The duplicate copy of the award letter duly signed with official stamp on all the pages to be submitted as a token of acceptance of the order.
- 2. The contractor shall also arrange for proper storage /handling of the equipment's at site, during supply, installation, testing and commissioning.
- 3. All precautions not to damage the Kalakshetra Foundation properties shall be taken by the contractor. If any damage is caused to any structure, building, trees etc. the same shall be made good by the contractor at his cost to the satisfaction of Kalakshetra Foundation authority concerned.
- 4. Some restrictions may be imposed by the security staff etc., on the working in the campus and for movement of labour, materials etc. The contractor shall be bound to follow all such restrictions/instructions and nothing extra shall be payable on this account.
- 5. The contractor shall be responsible for any accident at the site of work and consequences thereof.
- 6. It shall be deemed that the contractor shall satisfied himself as to the nature and location of the work, transport facilities etc. and the department will bear no responsibility for lack of such knowledge and the consequences thereof.

7. **General Terms of payment: -**

- a) Tender should be submitted in sealed cover along with the Earnest Money of ₹. 39,420/-(Rupees thirty nine thousand four hundred twenty only) and online as mentioned in KF's Bank account as per NIT. EMD submitted by other bidder/tenderers will be refunded within 15 days after the award of contract. No interest will be paid on the Earnest Money deposited with the Kalakshetra Foundation. Earnest Money deposit in respect of the successful tenderer will be retained with the Kalakshetra Foundation until entire work as per terms and conditions of the tender is completed. If the successful tenderer fails to execute the order strictly as per the terms and conditions of the tender, EMD shall be forfeited forthwith after cancellation of the concerned order. Tender document without EMD shall be treated as invalid and liable for outright rejection.
- b) Performance Guarantee /security deposit: Performance guarantee / Security deposit at the rate of 3% (three percentage) of the tender value shall be furnished within (4) four working days by the successful tenderer/ bidder/tenderer after receipt of award letter. Performance Guarantee should be in the form of Account Payee Demand Draft / Fixed Deposit / Banker's Cheque, Bank Guarantee from any of the Nationalized Banks or from any of the scheduled banks, validity for a period of six (6) months.
- c) Performance/Security deposit amount will not bear any interest of whatsoever. This performance/ security deposit amount will be refunded /released after the actual date of completion of work in all respects, after adjusting dues if any to the Kalakshetra Foundation from the contractor subject to terms and conditions as per the tender document.
- d) The performance / security deposit amount will be forfeited in case of breach of contract, deduction of any dues payable to Kalakshetra Foundation on whatsoever amount, deduction of any

liability / damages incurred by Kalakshetra Foundation, on behalf of the service provided / contractor in the discharge of his / their obligations under this tender or contract.

- e) No advance payments shall be released. Part bill payment for minimum value of Rs.10.00 Rupees Ten lakhs, shall be released based on progressive of work and work done as per the abstract bill value and certification. Final payment will be paid at the end of successful completion of work on submission of final bill, either by cheque or RTGS/NEFT within 30 (Thirty) working days.
- f) The defect liability period is 12 Months from the date of actual completion of work in all respects. 5% (Five percentage) security deposit /Retention amount on the total value of work will be deducted at the time of passing the bills. The retention amount withheld by KF will be returned/released at the end of defects liability period subject to the condition that there are no defects, repairs in the works done. No interest will be paid for the retention amount.
- g) Income Tax, GST TDS whichever is applicable at the prevailing rates as applicable from time to time shall be deducted as per extant rules. **Quoted rates should be inclusive of GST, all taxes as applicable in all respects.** No claim extra towards taxes, transportation etc. will be entertained.
- h) The prices quoted by the bidder/tenderer shall remain fixed during the entire period of contract i.e. **3 Months** and shall not be subject to variation on any account. Revision of rates will not be permitted for any reason during the original execution period. During the extended period if there is any excess expenditure towards tax, it has to be borne by the contractor but if any reduction the benefit will be passed on the Client / Kalakshetra Foundation.
- i) In the event of failure of work action will be taken to rescind the work and the work will be get through other agencies at contractor's risk and cost.
- j) During the progress of work, the Contractor/representative shall remain in touch with the Kalakshetra Foundation authorities and ascertain from them whether any excess over sanctioned cost is anticipated and/or has already occurred.
- 8. <u>Time of Completion</u>: 3 (three) months period from the date of handing over site / award letter. Time is the essence of the contract. If contractor fails to complete the work with in stipulated period, Liquidated Damage (L.D.) @2% of actual contract amount per day shall be recovered from the bill of the successful tenderer subject to a maximum of 10% of the contract amount/work order value.
- 9. **Insurance**: The contractor shall take all insurances at his cost to cover all kinds of risks from the time the materials / works till handing over to KF. Contractors all risk insurance inclusive of damage during transportation, fire, Storage, erection testing and commissioning policy for the full contract value. Workmen compensation policy for the employees of the contractor at site.

- 10. **TERMINATION OF AGREEMENT:** The agreement/work order herein may be terminated at any time by either party by giving a written notice of 15 days to the other party.
- 11. **ARBITRATION CLAUSE**: In the event of any dispute arising out of or in connection with this tender/contract/work order, whether during the subsistence of the contract or thereafter, the matter shall be referred to the Director, KALAKSHETRA FOUNDATION or any other officer nominated by the Director, KALAKSHETRA FOUNDATION for arbitration whose decision shall be final and binding on the parties. The proceedings before the Arbitrator would be governed by the provision of the Arbitration and Conciliation Act, 1996. The place of arbitration shall be Kalakshetra Foundation, Chennai.
- 12. The courts of Chennai will have exclusive jurisdiction for any issue/ dispute arising out of or in connection with the contract including relating to the arbitration proceedings.

SPECIAL CONDITIONS

- a. The Bidder/tenderer / supplier/ contractor should have similar experience in the field of civil works building extension works or similar works done.
- b. It shall be deemed that the contractor shall satisfied himself as to the nature and location of the work, transport facilities, availability of land for setting up of camp etc. The department will bear no responsibility for lack of such knowledge and the consequences thereof.
- c. **Electrical Power**: The electrical supply /connection in single source will be arranged by the Kalakshetra Foundation, provided the safety of the connection with proper EB board with standard details for the safety norms, separate electric consumption meter with controlling system and connected wiring has to be made available in the requisite area of working site by the contractor. The cost of the consumption of electrical units has to be paid by the contractor as per the conditions.
- d. Water supply for construction works: The contractor shall have to arrange for the water sources arrangements for the construction works or Kalakshetra foundation will be arranged for the water sources at a single point, storage arrangement has to made by contractor and charges will be deducted from the contractor bill as applicable.

ADDITIONAL CONDITIONS AND SPECIFICATIONS:

The additional specifications given below are not substitute to CPWD specifications or IS specifications. These shall be read along with CP W D specifications or IS specifications.

- 1. The work shall be carried out using metric dimensions only and shall be measured and paid in metric dimensions. F P S units, if any, mentioned in drawings etc. are for guidance only.
- 2. Wherever any reference to any Indian Standard Specification occurs in the documents relating to this contract the same shall be inclusive of all amendments issued there to or revision thereof if any, up to the date of receipt of bids.
- 3. Unless otherwise specified in the schedule of quantities the rates for the various items are for all heights and locations.
- 4. Unless otherwise specified in the schedule of quantities the rate for the items of the work shall be considered, as inclusive of pumping out or bailing out water, if required, for which no extra payments will be made. This will include water encountered from any source, such as rains, floods, sub-soil water table being high or due to any other cause whatsoever.
- 5. The bidders shall study the item description, the relevant drawings and satisfy him the item of work to be carried out.
- 6. The dismantling wherever required shall be done in a manner so that no other portions of the building or its fixtures are damaged. If any damage done to the building it shall be made good by the contractor at his own cost and no claim what so ever shall be entertained on this account.
- 7. The malba/garbage generated at site due to construction activities shall be removed from the Site to the location specified by Kalakshetra Foundation.
- 8. The contractor shall keep & clean the site thoroughly by removing scaffolding, surplus materials, rubbish, equipment left out of work and make clean clear the site around working site to the complete satisfaction of the Kalakshetra Foundation authorities before the work is treated as completed.
- 9. 11. The standard sectional weights referred to shall be as in Table 5.4 in para 5.3.4 in revised CPWD specifications 2009 Vol. I will be considered for conversion of length of various sizes of TMT bars in to standard weight.
- 10. The Contractor shall not stack building material / malba / muck/ rubbish on the land or road of the Kalakshetra Foundation campus. The muck, rubbish etc. shall be removed periodically as directed by the Kalakshetra Foundation authorities from the site of work.
- 11. All required materials like cement, steel, sand & stone aggregates, chips etc. shall be arranged for the works by the contractor. No material shall be issued by Kalakshetra Foundation.
- 12. All the tools, plants & safety of works arrangement will be borne by the contractor.

13. All the concrete works, mixture machine shall be used for lean concreting at the base, PCC and RCC works.

- 14. The safety measure arrangement for the safety of men and materials shall be made by the contractor as per site requirement at his own cost and risk.
- 15. The contractor shall use proper measuring box for mixing (volumetric ratio basis) of concrete ingredients and cement mortar work. The mixing of concreting work shall be undertaken in the presence of Kalakshetra authorities.
- 16. The contractor shall ensure adequate water proper curing days for the works i.e concrete works, brick work and finishing plastering works etc. as per standard days of curing as per the direction of Kalakshetra Foundation authorities.
