

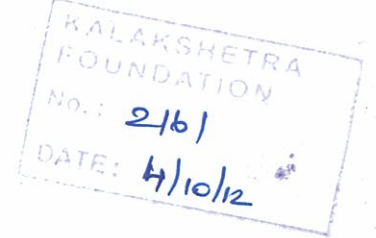

Office Note:

It was reported that the stone carving items have been sheltered in the temporary structure with casurina post / top covered with LDPE sheet, was collapsed due to heavy rain in the late night on 28.6.2012, resulting standing statue sculpture Dwarapalak had fallen in the standing position into ground along with the shed.

The collapsed shed bracing and supporting casurina posts were dismantled and stacked nearby. The damaged sand stone sculpture – Dwarapalaka – 2 nos were kept as it is position and covered.

One more temporary shed for sheltering the stone sculpture was also dismantled to avoid further damages to the stone sculptures.
