### Note

To consider and approve the revised detailed report amounting to Rs.4.63 crore for the balance works to be undertaken under phase-II of the Koothambalam Project

The revised detailed report amounting to Rs.4.63 crore as worked out to resume the balance works to be undertaken under Phase-II of the Koothambalam project was placed in the last finance committee meeting held on 09<sup>th</sup> February 2016.

During the aforesaid meeting, it was informed by Sh. Sanjiv Mittal, JS(Akd) that a letter had been written to Central Vigilance Commission to probe the Fact Finding report submitted by this office on Part-A of the Koothambalam Project and to submit the report thereon. Further to above, it was directed that a technical agency i.e CPWD office be engaged to submit the status report of all the works undertaken under Part-A of the Koothambalam Project and Certification for all works to be undertaken under Part-B of the Koothambalam Project.

In compliance to the direction of the Finance Committee, the CPWD office who was already involved by Kalakshetra Foundation in assisting in preparation of report under Part-A and Part-B of the Koothambalam Project was requested to provide the necessary certifications.

The CPWD office vide letter no.23(04)CCED-II/2016/2709 dated 26.02.2016 and vide letter no.24(28)K /CCDV/16/392 dated 02.03.2016 furnished the status report on Electrical and Civil works respectively on Part-A of the Koothambalam Project and vide letter no.23(785)/2015/CCCII/WII/874 dated 23.12.2015 furnished the certification of expenditure for Civil and Electrical under Phase-II of the Koothambalam Project. As regards, Sound, HVAC and stage lighting system, they expressed their inability to provide the necessary certifications as the said works were specialised nature of works and recommended to carry out with the original consultants.

It is submitted that the revised detailed estimates of Rs.4.63 crore has been worked out as per the advice of CPWD office.

The above report was placed before the Ministry. However the Ministry directed that the matter would be looked into after the investigation and submission of report on Part-A of the Koothambalam Project by Central Vigilance Commission.

The Central Vigilance Commission office in April 2016 carried out the technical audit and submitted the report thereon to the ministry in June 2016. On the basis of which Central Vigilance office under the Ministry of Culture office had also recently in June 2016 carried out the verification of the CVC report.

As the investigations by the ministry are under process to fix the responsibility for the lapses occurred under Part-A of the Koothambalam Project, it is requested that the



detailed report on Part-B of the Koothambalam Project as already submitted to the Ministry be approved in order to enable the completion of the long pending project stopped for last 04 years. This would also result in fructifying the expenditure of Rs.7.02 crore already incurred under Part-A of the Koothambalam Project. Further to above, it is ensured that all the norms under GFR be adhered for Phase-II of the Koothambalam Project.
